Sherif Foda is a shareholder and director of the Company's sponsor and shares voting and dispositive control over the securities held by the Company's sponsor, and thus shares beneficial ownership of such securities. Sherif Foda disclaims beneficial ownership over any securities owned by the Company's sponsor in which he does not have any pecuniary interest.
